**TREASURER'S REPORT:** Kate W. asked about the contribution page and if there is a formula for groups to follow for donations, Chuck T. explained that there is a suggested percentage, but no hard and fast rule. Murray P. asked about the drop in donations compared to last year, Chuck T. explained that last year Intergroup received a \$5,000 private estate donation, and that Intergroup actually received more than usual from groups for the month. Jesse M. asked if the Steering Committee has talked about buying new CDs, Ed O. explained that the Steering Committee has not formally met since the first motion to bring it to them.

**NEW BUSINESS:** Steve Y. asked why meetings were not longer listed in the Cape Cod Times, Jesse M. explained that the Cape Cod Times had been doing them as a public service, and once they started to do poorly, they could no longer do it for free. It was also going to cost too much for Intergroup to pay for an ad themselves. Joey B. motioned to have someone go to the Cape Cod Times to gather information about current costs, Deanie B. seconded, passed unanimously. Joey B. also volunteered to go.
